



## Undergraduate Guest Application for International 3+2 and Visiting Programs

*This application and instructions pertain only to undergraduate students who wish to participate in an established 3+2 or Visiting Program with the College of Business at the University of Michigan-Dearborn.*

### **Required Materials:**

- ✓ Copy of photo page of passport
- ✓ Official transcripts in English from all colleges or universities you have attended
- ✓ Official scores from ONE of the following English proficiency exams:
  - University-administered English language proficiency test score of 80% or higher
  - TOEFL score of at least 550 (paper), 213 (computer), or 80 (internet exam)
  - IELTS score of at least 6.5
  - MELAB score of 80

### **Obtaining a Student Visa:**

- ✓ Before entry to the United States is possible, international students must obtain an F-1 or J-1 student visa. Obtaining the visa requires that you submit financial certification indicating that you or your sponsor have sufficient funds to support your education at UM-Dearborn. You may either submit the required financial documents together with this application, or you may mail them directly to the Office of International Affairs at a later time. See <http://umdearborn.edu/cob/international-partners-ugradvisa/> for links to required forms and additional information.
- ✓ Estimated annual (8 month) expenses in US dollars are as follows:

Tuition and Fees = \$18,500  
Living expenses = \$11,400  
Books, Supplies = \$1,100  
Mandatory Health Insurance = \$1,000  
**Total of US \$32,000**

You must:

1. Submit an original bank certification (in English) or from your financial supporter, converted to U.S. dollars
2. If the financial certification is from your financial supporter, submit a certified letter (in English) from your financial supporter stating that the funds indicated on the financial certification will be used to support your tuition, fees, and living expenses while attending UM-Dearborn. The letter must show the original signature of the financial supporter.

International students must demonstrate full financial support before the UM-Dearborn I-20/DS-2019 form can be issued. Students who are admitted to an established 3+2 or Visiting Program are eligible to receive the program scholarship in effect at the time of admission.

Both F and J visa students are required to have valid health insurance while studying at UM-Dearborn. Please see <http://umdearborn.edu/692614/> for additional information.
